TERMS & CONDITIONS

1. OBJECTIVE

- 1.1. The present promotion, titled “Lucky Spin,” is a special action by Inkryptus, created in celebration of Pizza Day — a historic date in the crypto universe — with the purpose of honoring the community and encouraging use of the CoinFlip feature on the platform.
- 1.2. The initiative aims to provide a fun and potentially rewarding experience for users through an exclusive bonus on their first spin of the day.

2. DURATION

- 2.1. The promotion will be valid exclusively on May 22, 2025, from 00:00 to 23:59 (UTC).
- 2.2. Participants are encouraged to check their local time against the UTC schedule, as the promotion strictly follows Coordinated Universal Time.
- 2.3. After this period, the promotion will automatically end, regardless of prior notice.

3. ELIGIBILITY

- 3.1. All users with an active and verified Inkryptus account who play the CoinFlip game during the promotional period are eligible to participate.
- 3.2. No prior registration or activation is required to join; the bonus will be applied automatically according to the rules described herein.

4. COUNTRY / JURISDICTION RESTRICTIONS

- 4.1. Inkryptus reserves the right, at its sole discretion, to restrict, limit, or block access or participation from users located in jurisdictions where this promotion is prohibited, restricted, or contrary to local laws, administrative regulations, market rules, or authority guidelines.
- 4.2. It is the sole responsibility of the user to ensure their participation complies fully with all laws and regulations of their jurisdiction. By participating, the

user declares and guarantees that they are acting lawfully under their local legislation. Inkryptus is not liable for any civil, criminal, administrative, or regulatory consequences arising from the user's legal non-compliance.

5. PROMOTION MECHANICS

- 5.1. During the promotional period, the user will be eligible for the bonus in the CoinFlip game, provided the following criteria are met:
 - The spin must be made within the promotion period (May 22, 2025 – from 00:00 to 23:59 UTC – Coordinated Universal Time).
 - The first spin must result in a win (correctly guessing the chosen side of the coin).
- 5.2. If the above conditions are met, the user will receive **double the original net prize amount** for that spin.
- 5.3. The standard platform fee (Rake) will be applied proportionally to the total prize amount, according to the current CoinFlip rules.
- 5.4. In the event of a loss, the user will only forfeit the wagered amount, with no bonus or additional loss.
- 5.5. This promotion is valid **exclusively for the first CoinFlip spin** made by the user during the promotional period.
- 5.6. Any subsequent spins, even if performed on the same day, will automatically follow the standard CoinFlip rules and will not receive a bonus.

6. LIMITATIONS AND CONDITIONS

- 6.1. The bonus is limited to one rewarded spin per individual or user account, regardless of the use of multiple wallets, digital identities, or devices.
Inkryptus may use unique identifiers such as national ID documents, email addresses, phone numbers, IP addresses, device IDs, or any other verification criteria applicable to the participant's jurisdiction for enforcement purposes.
- 6.2. The promotion does not apply to subsequent spins made on the same day.
- 6.3. Only the **first winning spin** is eligible for the bonus.

- 6.4. If eligible, Inkryptus reserves the right to credit the bonus to the user's wallet within **up to 24 hours** after the winning spin, even if technical or operational reasons delay the instant deposit.
- 6.5. Inkryptus is not responsible for losses or inability to participate due to technical issues, connection failures, or service interruptions — it is the user's responsibility to ensure a stable connection.
- 6.6. Inkryptus may suspend, extend, or cancel this promotion at any time without prior notice.
- 6.7. The CoinFlip feature and this promotion are strictly for individuals aged 18 or older and residents of jurisdictions where gambling is legally permitted. The accuracy of the information provided upon registration is the sole responsibility of the user.

7. GENERAL PROVISIONS

- 7.1. This promotion is governed by the laws of the Federative Republic of Brazil, including but not limited to Law No. 13.756/2018 (regarding fixed-odds betting), the Civil Rights Framework for the Internet (Law No. 12.965/2014), the General Data Protection Law (LGPD - Law No. 13.709/2018), and other relevant regulations applicable to gaming, betting, and promotional campaigns.
- 7.2. The court of jurisdiction elected to settle any disputes arising from this promotion is Belo Horizonte/MG, Brazil, with express waiver of any other jurisdiction, regardless of privilege.
- 7.3. If the promotion reaches international users, it is the sole responsibility of the participant to ensure legal compliance under their local laws. This promotion is intended exclusively for users located in jurisdictions where games of chance and this type of promotion are expressly permitted. Inkryptus is not responsible for access or participation from countries where such practices are restricted or illegal. Users must ensure local legal compliance before participating.
- 7.4. Inkryptus may suspend, extend, or cancel this promotion due to force majeure, system failures, or risks to operational integrity.
- 7.5. The CoinFlip feature constitutes a game of chance and is only available to users aged 18 and older.

- 7.6. By using the feature, the user declares, under their responsibility, that they meet the minimum age requirement.
- 7.7. Inkryptus is not responsible for attempts to bypass age restrictions, including the creation of fake accounts or misuse of third-party identities to access CoinFlip or the promotion.
- 7.8. Inkryptus reserves the right to disqualify users attempting to manipulate or defraud the promotion mechanics, including through multiple accounts or other abusive practices.
- 7.9. Participations originating from masked IP addresses (VPNs or proxies) used to bypass territorial restrictions will be considered fraudulent and immediately disqualified.
- 7.10. Unforeseen or controversial issues will be evaluated by the Inkryptus team, whose decisions are final and binding.
- 7.11. Inkryptus encourages the responsible and conscious use of the CoinFlip feature. If users recognize signs of compulsive behavior, they are advised to stop participating and seek professional support. The platform reserves the right to implement usage limits if patterns of compulsive behavior, user risk, or platform integrity concerns are identified.
- 7.12. By participating in the promotion, the user freely authorizes the use of their username and prize amount received for institutional promotional purposes by Inkryptus, including digital platforms, social media, and marketing communications, unless otherwise explicitly stated.
- 7.13. The interpretation of these Terms & Conditions is under the exclusive authority of Inkryptus, and its decisions shall be final, definitive, and not subject to appeal.
